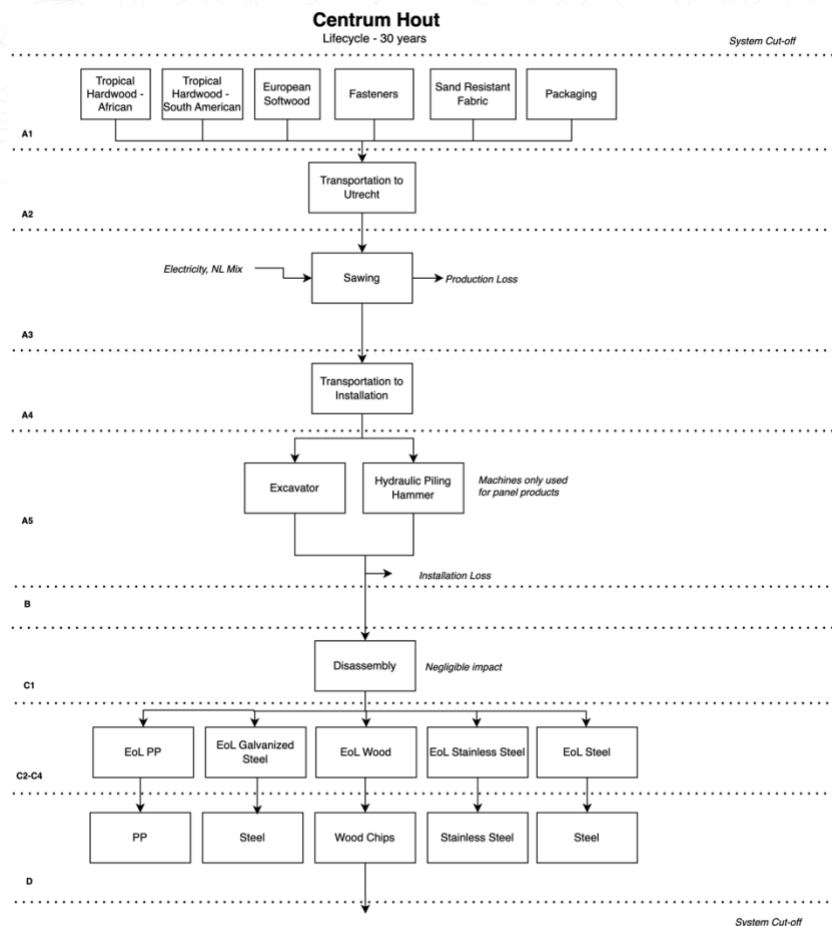

Detailed Product Description

General Product Information

A revetment consisting of horizontal planks that are attached to each other by means of vertical planks (cleats). Together with sand-resistant cloth, this forms a partition that is placed in place by means of poles, for example along waterways to retain the soil. The tropical wood used has a moisture percentage of $n=30\%$ (African) to $n=35\%$ (South American) and is air-dried. Rug wood and cleats both have a thickness of 20 mm. A post every 0,5 m and a cleat of 100 mm wide at least every meter. Mass is 84,61 kg per m²
