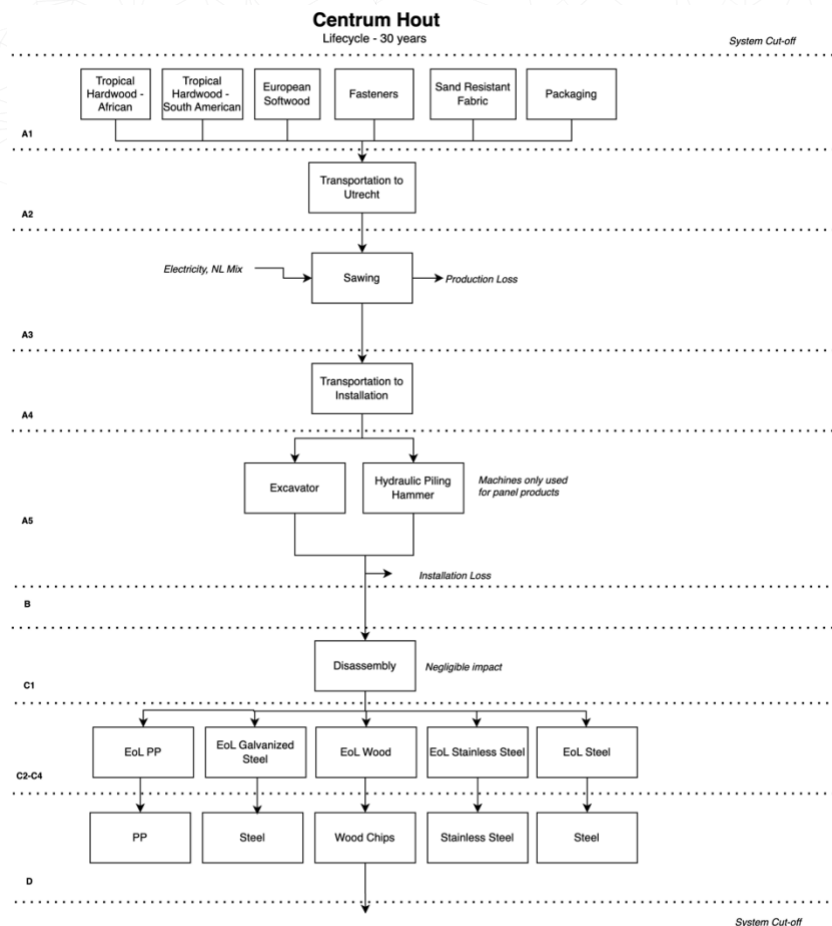

Detailed Product Description

General Product Information

A combined revetment consisting of horizontal planks that are attached to each other by means of vertical planks (cleats). Together with sand-resistant cloth, this forms a bulkhead that is placed in place by means of poles, for example along waterways to retain the soil. The combined version is largely the same as a revetment. The variation, however, is that the lower part of the horizontal planks has been replaced with European softwood. The tropical wood used has a moisture percentage of $n=30\%$ (African) to $n=35\%$ (South American) and is air-dried. The European softwood used has a moisture percentage of $n=15\%$. The weighted moisture percentage of this product card is $n=33,66\%$. Rug wood and cleats both have a thickness of 20 mm. A post every 0,5 m and a cleat of 100 mm wide at least every meter. Mass is 74,01 kg per m².
